

Current Cases & Criteria

Abiomed Impella Pumps

Insertion of heart pump during a hospitalization for serious cardiac condition and subsequently suffered a perforation during implant leading to death or serious injury.

Allergan Breast Implants

Use of textured recalled Allergan implants and one of the following: (a) diagnosis of BIA-ALCL lymphoma, (b) removal of implants due to symptoms or fear of BIA-ALCL lymphoma, or (c) removal due to physician recommendation.

BioZorb

The BioZorb breast biopsy marker has been recalled for its link to severe complications including device migration, erosion, chronic pain, infection, and seroma.

Baby Formula NEC

Diagnosis of necrotizing enterocolitis, surgery, other serious injuries or death following use of Similac or Enfamil to substitute breast milk for feeding premature infants from 2006 until present.

Depo-Provera

Must have used branded drug or authorized generic version of the drug at least 4 consecutive times and subsequently been diagnosed with meningioma or other brain tumor.

GLP-1 RA: Ozempic, Wegovy, or Rybelsus

Diagnosis of gastroparesis, stomach paralysis or gastric obstruction while taking the drug or within 30 days of stopping, and required ER visit or hospital admission.

Hair Relaxers

Diagnosis of uterine and/or ovarian cancer following minimum of 3 years of consistent use of a chemical hair relaxer containing endocrine disrupting chemicals.

Hernia Mesh

Use of Bard and/or Covidien mesh product (implanted in 2010 or later) that subsequently resulted in a mesh revision surgery or complete explant procedure.

Current Cases & Criteria

Human Trafficking

We are actively investigating legal claims on behalf of survivors against businesses (e.g., hotels, websites, truck stops, and similar establishments) that facilitated, enabled, or otherwise participated in the sex trafficking or sexual exploitation of the survivor.

Insulin Overpricing

Cities, Counties, States, unions, school boards, private employers and other large self-funded entities with direct pharmacy benefit management contracts with CVS Caremark, Express Scripts, or Optum either presently or in the last 5 years.

Oxbryta

Use of sickle cell disease drug within 1 month and suffered vaso-occlusive crises and injuries, including death, stroke, acute chest syndrome, multi-organ failure, or acute cardiac or pulmonary events.

PFAS

Drank from contaminated water supply from 1990 to present for at least 6 consecutive months and developed testicular, kidney, or liver cancer, or ulcerative colitis after 2000.

Social Media Harm

User began using social media before the age of 18, currently under the age of 25, uses or used social media regularly for 3 or more hours per day, and suffered from one or more of the following before the age of 21: eating disorder, body dysmorphia, self-harm, or suicidal ideation/attempt/completion.

Talcum Powder

Consistent use of Johnson's talc-based baby powder for at least 8 years. Must be 70 years old or younger with a 2021 or later diagnosis of fallopian tube cancer, ovarian cancer or Mesothelioma.

Tepezza

Diagnosis of permanent or persistent hearing loss or tinnitus following Tepezza use.

Ultra-Processed Foods

Diagnosis of Type 2 diabetes or non-alcoholic fatty liver / non-alcoholic steatohepatitis after significant consumption of ultra processed foods prior to the age of 18.
